Brief Guide to Publications Submitted

The publications submitted fall into two broad groups: those relating to Education, which form the bulk of the submission, and those to the field of Historical Geography. These two disparate groups of publications respresent my own academic training and interests. My first degree was in Geography and while I was at the University of Keele and subsequently at American universities, I taught both in the Education and Geography departments. Since coming to Loughborough in 1969, my research interests have been concentrated largely in the field of Education, although from time to time I have also written on Geographical subjects. My writings together form the core of a wide range of works which I have published over a period of twenty-five years and which in my view constitute a sustained, substantial and original contribution to knowledge.

1. Education

The most important group of publications in this field is the series of books which I have written with a former colleague, describing and analysing the organisation and provision of further education in England and Wales during the past twenty years (E1, E2, E4, E5 and E6). The study of educational policy and provision is one which has been much more strongly developed abroad, in countries such as the United States and Australia, than in Britain. Although in recent years a fairly extensive literature has grown up in this country, it has been very largely restricted to the school sector and to higher education. Indeed, as a subject of research, the further education sector and matters specifically relating to it have been very largely neglected (see, for example, the relevant chapters in E1, E2, E4, E5 and E6 and also E12, E13 and E17). For this reason, our books on the subject are virtually unique and their analysis of a very complex sector of our educational system has been described as "a guide through the labyrinth." Over the past twenty years they have come to

constitute an historical record of the development of our further education sector and are widely respected as definitive works on the subject, having acquired, in the words of a recent reviewer, "an unassailable authority." They have also attempted to draw comparisons with comparable developments in other countries and some years ago a very distinguished writer on the subject of comparative education described one of the books in the following terms: "In conclusion, one must repeat emphatically that this is a book of the highest importance and quality." Finally, the books are very widely used as prescribed and recommended reading for courses of initial and in-service training for further education and have been cited as authoritative works on the subject in a substantial range of books and articles.

They are supplemented by a group of booklets, contributions to books, and articles (E8, E9, E10, E12, E13, E24and E27) which deal with specific aspects of further education, such as teacher training, staff development, recurrent education, and research.

In the last few years I have enlarged the scope of my research to consider the comparative provision of further education, with specific reference to vocational education and training, in the developed world. The key publica ion in this respect is the book on the subject (E7), and a recent review by a respected writer on the subject states that, "It should be compulsory reading for anyone who wants to make things happen in the UKs vocational education and training, supplemented by a number of articles (E20, E22, E23, E25, E26, E27, E28 and E29). Once again, this is a field about which relatively little has been written in this country and, to that extent, this body of work represents the breaking of new ground.

In addition, I have written in a more popular vein, about the history of Loughborough University of Technology and its predecessors (E3, E11, E15 and E16) in a manner which endeavours to cast light both upon the particular and very interesting history of the institution itself and also upon the historical context in which its development took place.

Finally, stemming from my research thesis on the contribution to the history of geographical education of Halford Mackinder, perhaps the most distinguished geographer and geo-politician which this country has yet produced, I have written some articles on his work (E18, E19 and E21).

2. Geography

My major interest has been in the identification and mapping of an important element in the English medieval landscape, namely the deer park, whose primary function was as a hunting ground. Medieval hunting parks were very numerous, existing in every county in England, and have left various traces on the modern landscape including field-names, fieldboundaries and, in some cases, earthbanks. Prior to my work on the subject, which has extended over the past 30 years, very little was known about them; now their significant contribution to the medieval landscape is better appreciated and understood,⁵ and has led to a number of studies of medieval parks in various parts of the country, by post-graduate students and others. My research was initially based on the examination of a wide range of documentary evidence and on detailed fieldwork, beginning in Dorset, and extending to other counties such as Staffordshire, Leicestershire, Berkshire and Buckinghamshire. This work was undertaken both on my own and in collaboration with others and resulted in a series of articles in county historical and archaeological journals (see, for example, G6, G7 and G14). Eventually, a general analysis of the subject appeared in Geography (G12) and a county-bycounty gazetteer of medieval parks was published (G5). My interest in parks naturally led me to examine the other, more extensive, medieval hunting grounds, namely forests, chases, and warrens. The forests and chases of Staffordshire and Rutland respectively are described in articles and in local journals (G10 and G15) and a general appreciation of their contribution to the medieval landscape is to be found in Chapter 3 of my edited book, The

English Medieval Landscape (G2). I have also made some analyses of the part played by castles in the medieval landscape, both in Staffordshire and Leicestershire (G8 and G11) and in the country as a whole, in Chapter 5 in *The English Medieval Landscape*. Both this book and that on the historical geography of the English countryside between 1400 and 1700 (G3) attempt to paint a broader picture, as does the chapter in an edited book on the medieval landscape of Staffordshire (G4).

Finally, over the years I have written from time to time on the geography of irrigated agriculture. The most substantial contribution to this subject, which has been largely neglected by academic geographers, is my book, *A World Geography of Irrigation* (G1), which was well received both in this country and abroad.⁶ In addition, I have contributed a few articles on American examples of irrigated agriculture (G9 and G12).

1. Education

As will be seen, the books on further education in England and Wales, and a number of chapters and articles on the subject, were prepared jointly with I.F. However, in every case they were written wholly by me.

2. Geography

A number of the articles on medieval parks were written in collaboration with others, whose contribution was because they either had particular knowledge of the relevant economic history or of the local area.
